Northern Colorado Water Conservancy District Deployed MHC Software's Document Management Solution with Infor 10

Northern Water is a public agency created in 1937 to contract with the federal government to build the Colorado-Big Thompson Project. The C-BT provides supplemental water to more than 640,000 acres of irrigated farm and ranch land and about 850,000 people in Northeastern Colorado.

Northern Water and the U. S. Bureau of Reclamation jointly operate and maintain the C-BT, which collects water on the West Slope and delivers it through a 13-mile tunnel beneath Rocky Mountain National Park to portions of eight Northeastern Colorado counties. In addition to operating and maintaining the C-BT, Northern Water collects, distributes and monitors weather and water quality data, tracks stream flows and reservoir levels, and provides water resource planning and water conservation information.

Challenge

- Users had no direct access to invoices after they were paid, nor the supporting receiving documents and AP check copies
- · Experienced persistent invoice backlogs and payment delays while invoices sat on approvers' desks

Solution

- Northern Water selected MHC's document management solution, including Document Express[™] for AP, Payroll, tax forms and purchase orders and MHC Image Express[™] for incoming AP invoices and receiving documents

- The deployment of MHC software solutions fit in seamlessly with the Infor 10 implementation project plan

- AP eliminated the manual routing of invoices
- Use of MHC Workflow invoice approval reminder emails has reduced the time Accounts Payable has to spend following up on invoices that are not completed in a timely manner

- Electronic workflow limits approvers' access only to valid GL and Activity accounts
- Users have online access to invoices, purchase orders, payment history and any other related scanned images, reducing time spent on research and analysis
